## Economic Development Report – Palestine Mall

City of Palestine extended time for potential mall pad site closing to April 30, 2017. The potential developer is working on leases with tenants now.

# Economic Development Report - Recruitment

Taco Casa is planning to locate on a site at US Highway 79 and Knox adjacent to Family Dollar by end of January 2017.

Two fast food restaurant chains and one retail service chain contacted PEDC with site location requests.

#### <u>Economic Development Report – Community Development</u>

Councilman Joseph Thompson is working with Anderson County concerning a bike path located in Davey Dogwood Park.

#### Main Street Report

Wine Swirl 2016 takes place December 10, 2016, a Saturday, from 4pm to 8pm, with VIP sparkling wine reception in Old Town behind Oxbow Bakery from 8pm to 10pm. We have great sponsors this year and tickets are almost sold out. Red Hat Rentals and Ben E. Keith are our largest in kind sponsors.

A reminder to everyone that we have matching grant funds for bat houses, and our City owned bat house located in front of our local Chamber of Commerce office is our example for the community. One bat house hold approximately 1,000 bats.

Façade Grant applications will be available by January 2017, a full three months earlier than usual.

Downtown Assessment Study is due soon for distribution. Jacob Morris provided historic information to our vendor for their reporting purposes.

Monument railroad project has sold 50 bricks so far.

## Tourism Report

List of Daily Tourism Notes provided to demonstrate activity at our Palestine Visitor's Center.

12 month calendar provided showing activities and paid advertising for Visit Palestine.

Talked about the social media campaign for our holiday season that targets Waco, Shreveport, Houston, Dallas, and Austin areas.

The Anderson County Jail will be filmed in January 2017. We will also have filming of some of the Frost Fest activities, particularly the Tour of Homes. Curious Museum opened in new location Nov. 28, 2016.
