2. Vice-Chairman Chris Carter recognized the Secretary-Treasurer, who stated that periodically the ARC will request assistance from the Public Works Department for carrying out their operations. She then stated that they have an old compactor that needs to be transported and they are requesting assistance from the Parish to transport the two (2) old compactors to Southern Scrap yard in Houma. The Secretary-Treasurer then stated that the ARC is also inquiring about assistance with their Christmas Tree Program in the later part of the year. She stated that they have relied on the Police Jury for trustee labor to unload, etc. and they are confirming that the resource would still be available. She then stated that after speaking with the ADA, he suggested that a Cooperative Endeavor Agreement be put in place for both matters.
3. Committee member Booster Breaux offered a motion, seconded by Mr. Jeff Naquin, 'THAT, the committee approve a Cooperative Endeavor Agreement to assist the ARC with the periodic assistance from the Public Works Department throughout the year.' The motion was unanimously adopted.
4. Committee member Jeff Naquin offered a motion, seconded by Mr. Booster Breaux, 'THAT, there being no further business to come before the Road & Bridge Committee, the meeting be adjourned.' The motion was unanimously adopted.

Finance Committee Meeting
Of the
Assumption Parish Police Jury

4:25 O'clock p.m.

1. Committee members recorded as present were: Mr. Martin Triche, Chairman; Mr. Ron Alcorn, Mr. Jeff Naquin, Mr. Booster Breaux.
Committee member recorded as absent was: Mr. Henry Dupre.
Other Police Jurors recorded as present were: Mr. Irving Comeaux, Mr. Chris Carter.
2. Committee member Booster Breaux offered a motion, seconded by Mr. Jeff Naquin, "THAT, the committee approve payment of the bills submitted through April 7, 2017." The motion was unanimously adopted.
3. Chairman Martin Triche recognized the OHSEP Director, who stated that there was an Emergency Code Council meeting on Monday where all 6 parishes and South Central Planning met to discuss the change in the way the fees are administered in relation to building codes. He then stated that concerns of the new rates were brought up in relation to warehouse buildings and the response by SCP and the Administration Team met with the different parishes and proposed a different way to administer the program. He proceeded to explain that a \$18 million budget is set to administer the program and divided between the jurisdictions that are included in the region. He stated that Assumption Parish makes up 8.73% of the region's population being served and their contribution equates to \$157,135.04 annually. He then stated that this amount is being proposed as the annual fee that the Parish is responsible to pay SCP for the Plan Review, inspection and administration of the building codes. He added that this changes the current 80/20% method. The OHSEP Director then stated that the Parish would be responsible for setting any fee or revenue and retain 100% of any fees collected. He then stated that he and the Secretary-Treasurer reviewed the previous budget and it's an increase of approximately \$15,000. He advised the committee that Terrebonne met and adopted their portion of the fee. In response, Kevin Belanger, CEO of South Central Planning Development and Commission stated that Terrebonne Parish sees the changes that were made in October as increases however, we contend that the changes that were made are not increases when you look at the overall permitting. He further explained that the reason for change was the under valuating of the permit fee which brought down collections throughout the region.
4. Committee member Henry Dupre entered the meeting at this time.
5. Mr. Belanger stated that the budget in 2007 of \$1.8 million still exist today which was achieved through better efficiency deployed with a multi discipline staff of inspectors. In response, he stated that the parishes should see a slight increase in the overall collections in commercial. The Secretary-Treasurer informed the committee that the OEP budget cannot cover this fee therefore, when the budgets are done it will affect the transfer in from General Fund. She also stated that if there is more in receipts, then that transfer will not be necessary. A brief discussion and clarification was then held regarding the change in fees as they relate to the administration of the building codes. Following the discussion, the committee agreed to accept the change (flat fee) that was presented.
6. Committee member Jeff Naquin offered a motion, seconded by Mr. Ron Alcorn, "THAT, the committee approve the update as set by the Emergency Code Council for the Administration of Building Code fees." The motion was unanimously adopted.
7. Chairman Martin Triche stated that several conversations have been held with the Sheriff and the ADA regarding the request from the Sheriff relative to reimbursement for nursing cost at the jail. He stated that the Jury has pondered on what's the best and efficient way to handle the situation. He then stated that the Parish has nothing in place at this time to replace the system that is currently in place therefore, he would recommend that the Police Jury agree to reimburse for the foreseeable future actual cost at a cap of up to \$8,500 monthly and still explore other options or methods to save cost.
Committee member Ron Alcorn stated that he reviewed last year's budget and the total paid for nursing cost was \$95,082. He stated that the current request is for \$7,000 more and asked why the last year's cost would not be sufficient.
In response, the Sheriff stated that the figures that were presented from last year's budget were only estimated costs but those presented for 2017 reimbursements were actual costs.
A brief discussion was held regarding the amount being requested. In response, the Sheriff stated that they have removed the request for reimbursement for Courtroom Security.
In response to DOC invoices, the Sheriff stated that the Police Jury should not be receiving medical invoices for DOC but if they are received, he asked that they be forwarded to his office.
8. Committee member Booster Breaux offered a motion, seconded by Mr. Henry Dupre, "THAT, the committee approve a Cooperative Endeavor Agreement reimbursement of actual cost up to

\$8,500 monthly to the Sheriff's Office for nursing costs at the jail with the option to explore other methods to save on the cost." The motion was unanimously adopted.

9. Chairman Martin Triche recognized the Secretary-Treasurer, who stated that Civic Source agreed to notify the Police Jury monthly on the progress they are having with the adjudicated properties. She stated that for the month of April there are 3 current candidates, 29 public properties, 3 properties in research, 3 properties scheduled for May 3, 2017 auction, 1 for May 10, 2017, 1 for June 7, 2010, and 3 for June 14, 2017.
10. Committee member Jeff Naquin offered a motion, seconded by Mr. Booster Breaux, "THAT, the committee approve the Civic Source monthly report as presented." The motion was unanimously adopted.
11. Chairman Martin Triche recognized the Secretary-Treasurer, who stated that in the past the Parish has always had two issued credit cards in the Assumption Parish Police Jury name along with her name and John Boudreaux. She then stated that the renewed card only came in her name and after contacting the credit card company, she was informed that she has to send authorization for a 2nd card to be issued in John's name. Therefore, she is requesting authorization from the Jury to send the information requesting the duplicate card for the OHSEP Director.
12. Committee member Booster Breaux offered a motion, seconded by Mr. Henry Dupre, "THAT, the committee approve the request for a duplicate credit card in the name of OHSEP Director, John Boudreaux." The motion was unanimously adopted.
13. Police Juror Patrick Johnson entered the meeting at this time.
8. Chairman Martin Triche recognized the OHSEP Director, who stated that he has been meeting with C.J. Savoie about a potential building to store all of the parish equipment which is currently stored at the Ag Center. He then stated that they are proposing constructing a utility warehouse with 4 bay doors at the #2 yard. He stated that he would propose to move and store the culverts to the Bertrandville yard on Ezekiel St.
Chairman Martin Triche stated that he met with the OHSEP Director and yes there is a lot of equipment stored at the Ag Center but the #2 yard is in disarray and if cleaned and re-organized and a small amount of renovation made, they may be able to store the majority of the equipment at the site without having to construct a new building.
Committee member Booster Breaux stated that the Parish is watching the budget due to the extra expenditures that we have been hit with therefore, if there are existing buildings that can be renovated to provide the same warehouse storage space as being proposed, he would recommend usage.
Chairman Martin Triche added that the funding that would be used from the Special Industry Fund can be used to assist with something else in the future.
A brief discussion was then held regarding what is currently being stored at the proposed yard, the clean up process, and an estimate cost to renovate. Following the discussion, the committee agreed to table the matter until the clean up process takes place at yard 32.
9. Committee member Jeff Naquin offered a motion, seconded by Mr. Booster Breaux, "THAT, the committee approve to table the request to contract with CJ Savoie for the construction of a utility garage." The motion was unanimously adopted.
10. Committee member Jeff Naquin offered a motion, seconded by Mr. Booster Breaux, "THAT, there being no further business to come before the Finance Committee, the meeting be adjourned." The motion was unanimously adopted.

2. Chairman Irving Comeaux recognized the OHSEP Director, who stated that the plat was presented requesting approval for four (4) lot extensions on Jolimar St. He stated that since they are not adjacent to the road, the lots are to be sold to the adjacent landowners. He then recommended that the request be approved.

3. President Martin Triche led the Prayer and Police Juror Chris Carter led the Pledge of Allegiance to the Flag.
4. Police Juror Booster Breaux offered a motion, seconded by Mr. Ron Alcorn, "THAT, the Police Jury approve the minutes of March 22, 2017 meeting." The motion was unanimously adopted.
5. President Martin Triche opened the meeting to the public for any public comments, questions or concerns regarding the items listed on the agenda. Following three (3) calls, there were no comments received.
6. President Martin Triche recognized Road & Bridge Committee Vice-Chairman Chris Carter, who stated that the committee met and approved a Cooperative Endeavor Agreement to assist the ARC with periodic assistance from the Public Works Department throughout the year..
7. Police Juror Chris Carter offered a motion, seconded by Mr. Ron Alcorn, "THAT, the Police Jury approve the Road & Bridge Committee report as presented." The motion was unanimously adopted.
8.
